
With 2023 behind us, I believe it's important to celebrate all we've achieved for our community, our state and our great country during my past year in Congress.

LOCAL PROJECTS

As your Representative, my top priority is advocating at the federal level for projects and grants directly impacting our communities.

Secured [\\$3 million in Congressional Appropriations](#) to fully fund the U.S. Army Corps of Engineers Civil Works (USACE) study to help begin planning and designing critical stormwater and flood protection projects for the City of Daytona Beach. This project will help restore and rebuild Daytona Beach's infrastructure to mitigate the impacts of flooding.

It's the duty of our elected officials to provide for constituents and their safety. The following **grants** were awarded to our district from the Department of Health and Human Services (HHS):

- ***Rural Health Care, Inc. in Palatka*** was awarded a **\$1,670,197 grant** through the Health Center Cluster Program
- ***Rural Health Care, Incorporated in Palatka*** was awarded a **\$589,000 grant** through the Fiscal Year 2023 Capital Assistance for Hurricane Response and Recovery Efforts (CARE) program, a program that provides funding for capital improvement work to assist health centers located in areas impacted by hurricanes Fiona and Ian
- ***Rural Health Care, Inc. in Palatka*** was awarded a **\$78,206 grant** through the Fiscal Year 2023 Bridge Access Program, a program which aims to help maintain uninsured individuals' access to COVID-19 care at their local pharmacies, through existing public health infrastructure, and at their local health centers
- ***St. Johns River Rural Health Network, Inc. in Palatka*** was awarded a **\$500,000 grant** through the Rural Communities Opioid Response Program Neonatal Abstinence Syndrome program to help reduce the morbidity and mortality of substance use disorder (SUD), including opioid use disorder (OUD) in high risk rural communities
- ***Northeast Florida Health Services, Inc. in Deland*** was awarded a **\$1,659,833 grant** through the Health Center Cluster Program
- ***Northeast Florida Health Services, Inc. in Deland*** was awarded a **\$51,964 grant** through the Fiscal Year 2023 Bridge Access Program, a program which aims to help maintain uninsured individuals' access to COVID-19 care at their local pharmacies, through existing public health infrastructure, and at their local health centers
- ***SMA Behavioral Health Services, Inc. in Daytona Beach*** was awarded a **\$545,000 grant** through the SMA Family TREE 2021 program, a program which aims enhance and expand comprehensive treatment, early intervention, and recovery support services for youth with substance use disorders (SUD) and/or co-occurring substance use and mental disorders (COD), and their families/primary caregivers

Our district has such amazing universities and colleges that not only contribute to the success of our area, but the country as a whole. The following **grant** was awarded to our district from the Department of Education:

- ***Daytona State College*** was awarded a **grant of \$31,491** through the School Emergency Response to Violence (Project SERV) Program, a program that funds short-term and long-term education-related services for local educational agencies (LEAs) and

institutions of higher education (IHEs) to help them recover from violent or traumatic events in which the learning environment has been disrupted

If we want to continue growing and innovating, the American science, technology, engineering and math (STEM) workforce must meet the demands of our growing STEM industries. The National Science Foundation (NSF) awarded the following **grants**:

- ***Embry-Riddle Aeronautical University*** was awarded a **\$380,418 [grant](#)** to fund an intense 10-week Unmanned Aerial Vehicles (UAV) cybersecurity research program to prepare students for future cybersecurity careers and graduate schools
- ***Embry-Riddle Aeronautical University*** was awarded a **\$162,492 [grant](#)** to fund research into better understanding monsoon thunderstorm activity and precipitation in the Southwest
- ***Embry-Riddle Aeronautical University*** was awarded a **\$20,000 [grant](#)** to fund a research project to address two fundamental issues: limited access to aviation big data; and shortage of a robust workforce with integrated big data analytics and aviation competencies
- ***Embry-Riddle Aeronautical University*** was awarded a **\$556,507 [grant](#)** to investigate human driving behavior and interactions among traffic participants, with the aim of empowering technological advances in autonomous and connected vehicles
- ***Embry-Riddle Aeronautical University*** was awarded a **\$577,370 [grant](#)** to support research to build a better understanding of Musculoskeletal disorders and diseases, through the development of a novel framework to evaluate growth and development of the hip joint in infants
- ***Embry-Riddle Aeronautical University*** was awarded a **\$485,054 [grant](#)** to use spacecraft observations, numerical simulations and laboratory experiments to study how solar wind plasma– the electrons and ions blowing off the surface of the Sun– interact with the magnetosphere of the Earth
- ***Embry-Riddle Aeronautical University*** was awarded a **\$50,000 [grant](#)** to test the foundations of General Relativity
- ***Embry-Riddle Aeronautical University*** was awarded a **\$451,683 [grant](#)** to study magnetic reconnection and the Kelvin-Helmholtz Instability (KHI) phenomena to provide insight into the importance of Earth's dipole as a function of time for plasma transport across the magnetopause, the Ionosphere dynamic, and its implications for understanding space weather
- ***Embry-Riddle Aeronautical University*** was awarded a **\$400,000 [grant](#)** to serve the national interest by improving student engagement and student learning outcomes for engineering students in engineering graphics, a foundational course in many engineering programs
- ***Embry-Riddle Aeronautical University*** was awarded a **\$23,283 [grant](#)** to enhance the sensitivity of Cosmic Explorer (CE), the proposed third generation gravitational wave detector
- ***Embry-Riddle Aeronautical University*** was awarded a **\$159,926 [grant](#)** to research the structure and properties of C*-algebras associated to quantum graph in quantum mechanics

- ***Embry-Riddle Aeronautical University*** was awarded a **\$61,300 [grant](#)** to a three-year study about engineering intuition conducted at Bucknell University, Arizona State University, and Embry Riddle Aeronautical University
- ***Embry-Riddle Aeronautical University*** was awarded a **\$399,183 [grant](#)** to broaden the implementation of undergraduate research, improve student perspectives, and promote STEM career pathways
- ***Embry-Riddle Aeronautical University*** was awarded a **\$716,747 [grant](#)** to address compelling science questions related to Atmospheric Gravity waves (GWs) dynamics by using novel observations and machine learning methods
- ***Bethune-Cookman University*** was awarded a **\$200,000 [grant](#)** to support and strengthen STEM undergraduate education and research at Historically Black Colleges and Universities (HBCUs)
- ***Bethune-Cookman University*** was awarded a **\$300,000 [grant](#)** to support junior and mid-career faculty at Historically Black Colleges and Universities who are building new research programs or redirecting and rebuilding existing research programs
- ***Stetson University*** was awarded a **\$502,998 [grant](#)** to encourage the next generation of scientists by allowing them access to research experiences where they will identify mechanisms of yeast fusion that can aid in the understanding of cell fusion in mammals
- ***Stetson University*** as awarded a **\$1,000,000 [grant](#)** to establish a pilot GSI bioswale and associated hydrologic monitoring system at Veterans Memorial Park in the City of Cape Canaveral to guide design, implementation, and monitoring protocols within subsequent GSI projects in Cape Canaveral and other similarly situated coastal communities in the Indian River Lagoon watershed of eastern Florida

The National Science Foundation (NSF) awarded a **\$254,493 [grant](#)** to Botelmot Research LLC in Ormond Beach to advance oyster reef restoration efforts by improving the understanding of oyster reef formation at the individual level and improving the resilience of waterfront infrastructure including small docks.

Led [letter](#) to Department of Transportation Administrator for Federal Aviation Administration Steve Dickson to urge support for Daytona Beach International Airport (DAB) and their application to the FAA's Airport Terminal Program (ATP) for construction of a replacement Integrated Security Management System (ISMS).

COASTAL & WATER INFRASTRUCTURE

Floridians know the impacts of water quality, coastal flooding and beach erosion on our communities. We must continue to protect the environment and all that makes Florida beautiful.

Introduced the [American Shores Protection Act of 2023](#) to codify the moratorium on oil and gas drilling off the coasts of Florida that was put in place by a September 8, 2020 Executive Order by then-President Trump. Under the legislation, the moratorium would apply to the South Atlantic, Eastern Gulf, and Straits of Florida planning areas.

Led a [Florida delegation](#) request and introduced the [Clean Water Allotment Modernization Act of 2023](#) to update the Clean Water State Revolving Fund (CWSRF) formula, which determines

the amount of money states receive for water quality projects. The current formula has not been updated since 1987, keeping Florida from receiving the funding needed to keep water clean.

Cosponsored the [REEF Act](#) to require the Department of the Navy to notify Congress of the pending retirement of vessels that are viable candidates for artificial reefing (intentionally sinking a vessel to promote marine life).

Cosponsored the [Coastal Communities Ocean Acidification Act of 2023](#) to require the National Oceanic and Atmospheric Administration (NOAA) and the Ocean Acidification Advisory Board to collaborate with various entities affected by ocean acidification and coastal acidification (i.e., the decrease in pH and changes in water chemistry of certain bodies of water and waterways).

Cosponsored the [Combat Harmful Algal Blooms Act](#) to include algal blooms within the definition of major disaster under the Robert T. Stafford Disaster Relief and Emergency Assistance Act and directs the Centers for Disease Control and Prevention to submit to specific congressional committees a detailed study relating to the health effects of exposure to cyanotoxins in the air that result from algal blooms.

Cosponsored the [Youth Coastal Fishing Program Act of 2023](#) to direct the National Oceanic and Atmospheric Administration to establish a grant program to fund youth fishing projects for urban and underserved communities.

Signed [letter](#) to President Joseph Biden to request an allocation of \$725 million under the Army Corps of Engineers construction account for South Florida Ecosystem Restoration.

FLORIDA & AMERICAN INFRASTRUCTURE

Since becoming a Congressman, I've fought to provide North Central Florida with Federal Emergency Management Agency (FEMA) reimbursements to help cover the cost of preparing, recovering, and rebuilding after Hurricanes Matthew, Irma, Dorian, and now Ian, Nicole, and Idalia.

Introduced the [Condemning Secretary of Transportation Pete Buttigieg](#) to express that Secretary Pete Buttigieg has failed to keep the American people safe in his duties as Secretary of Transportation, has failed to ensure goods flow efficiently through the U.S. economy, has lost the confidence of the American people, and should resign.

Cosponsored the resolution [Celebrating the 75th anniversary of the National Association for Stock Car Auto Racing \("NASCAR"\)](#).

Cosponsored the [Expressing support for the designation of May 2023 as Motorcycle Safety Awareness Month](#) resolution.

Cosponsored the [Collision Avoidance Systems Act of 2023](#) to protect drivers and ensure vehicles are equipped with functional automatic braking systems that can help avoid rear-end crashes.

Cosponsored the [*Saracini Enhanced Aviation Safety Act*](#) of 2023 to require the Federal Aviation Administration to issue an order requiring installation of a secondary cockpit barrier on commercial passenger aircraft.

Cosponsored the [*Fair and Open Skies Act*](#) to ensure that authorizations issued by the Secretary of Transportation to foreign air carriers do not undermine labor standards.

Cosponsored the [*To amend title 46, United States Code, to include the replacement or purchase of additional cargo handling equipment as an eligible purpose for Capital Construction Funds, and for other purposes*](#) resolution.

Cosponsored the [*National POW/MIA Memorial and Museum Act*](#) to designate the memorial and museum that is being constructed on an approximately 26-acre area on the POW-MIA Memorial Parkway in Jacksonville, Florida, as the National POW/MIA Memorial and Museum.

Cosponsored the resolution [*To designate the facility of the United States Postal Service located at 207 East Fort Dade Avenue in Brooksville, Florida, as the "Specialist Justin Dean Coleman Memorial Post Office Building"*](#).

Cosponsored the resolution [*To designate the facility of the United States Postal Service located at 109 Live Oaks Boulevard in Casselberry, Florida, as the "Colonel Joseph William Kittinger II Post Office Building"*](#).

Cosponsored the resolution [*To designate the facility of the United States Postal Service located at 859 North State Road 21 in Melrose, Florida, as the "Pamela Jane Rock Post Office Building"*](#).

Cosponsored the [*Beautifying Federal Civic Architecture Act*](#) to establish the President's Council on Improving Federal Civic Architecture.

Cosponsored the [*Sunshine Protection Act of 2023*](#) to make daylight saving time the new, permanent standard time.

Signed [letter](#) to House Speaker Mike Johnson and Senate Republican Leader Mitch McConnell to raise concern over the Environmental Protection Agency (EPA) proposal to effectively require over two-thirds of all vehicles sold in the United States be fully electric in less than nine years.

VETERANS

As the Chairman of the House Armed Services Committee on Readiness and a veteran myself, I worked hard to help pass legislation worthy of those who have and continue to sacrifice so much to preserve our freedoms.

Led over 30 bipartisan Members of Congress to wash the Vietnam Memorial Wall in Washington D.C. to honor fallen service members.

Cosponsored and Signed into Law the [*250th Anniversary of the United States Marine Corps Commemorative Coin Act*](#) to direct the Department of the Treasury to mint and issue not more than 50,000 \$5 gold coins, 400,000 \$1 silver coins, and 750,000 half-dollar clad coins emblematic of the 250th anniversary of the United States Marine Corps.

Cosponsored the [*Not Just a Number Act*](#) to require Veterans Affairs (VA) to examine veterans' benefits usage in their annual suicide prevention report, in order to evaluate the relationship between VA benefits and suicide outcomes.

Cosponsored the [*VET CARE Act of 2023*](#) to create a four-year pilot program providing dental care for Veterans with certain chronic health conditions. Right now, dental care through the VA is limited to those who are 100% disabled or have a direct service connected injury.

Cosponsored the [*VA Loan Informed Disclosure Act of 2023*](#) to require a Federal Housing Administration mortgage notice to contain comparative rate and fee information about loans available under the Department of Veterans Affairs home loan program, so veterans can make an informed decision when making a home purchase.

Cosponsored the [*Purple Heart Freedom to Work Act*](#) to ensure combat-disabled veterans are not penalized for re-entering the workforce. Specifically, the legislation raises the monthly income threshold before it affects their Social Security Disability Insurance benefits.

Cosponsored the [*Major Richard Star Act*](#) to allow medically retired combat-disabled veterans with fewer than 20 years of service to concurrently receive veterans' disability compensation and retired pay.

Cosponsored the [*Honoring the service and sacrifice of America's veterans on Veterans Day, 2023*](#) resolution.

Cosponsored the [*Acknowledging the courage and sacrifice of veterans of the Korean War and Korean Defense Veterans*](#) resolution.

Cosponsored the [*Expressing support for designation of a Welcome Home Vietnam Veterans Day*](#) resolution.

Signed [letter](#) to Metropolitan Washington Airports Authority to object to the removal of fee-free parking for Honor Flight of veterans visiting Washington, D.C. The Airport Authority reversed its decision.

NATIONAL SECURITY

Provided resources to the U.S. military, first responders, and allies to ensure our freedoms and liberties remain unbridled.

Signed into law the [*Fiscal Year 2023 National Defense Authorization Act*](#) (NDAA), which repeals the vaccine mandate for our troops that has crippled military readiness, increases pay for our warfighters, supports American troops, and provides resources to the Department of Defense, Department of Homeland Security, NASA, and related agencies to invest in modern defense systems, support American troops, defend assets in space, and strengthen border security.

The [*Fiscal Year 2023 NDAA*](#) included many of my provisions and policy goals to:

- Authorize joint, commander level, multi-domain, interoperable military exercises with Taiwan to help prepare and protect the island from potential Chinese military aggression
- Permanently prohibit purchases of goods by the Defense Department from the Xinjiang Uighur Autonomous Region in China
- Require the universities in China that support the Chinese Communist Party's military to be identified and listed by the Defense Department and intelligence agencies
- Allocate funding for new construction projects at Florida military bases, including Patrick Space Force Base, Camp Blanding Joint Training Center, MacDill Air Force Base, and Eglin Air Force Base
- Set gender-neutral fitness standards for combat military occupational specialties in the U.S. Army
- Ensure critically injured members of the Armed Forces are afforded protections, privileges, and rights to due process through the Wounded Warrior Bill of Rights
- Expand the Defense Department's stockpile of rare-earth elements and critical minerals and require country of origin disclosures,
- Prohibit abandonment of K9s on the battlefield and accountability requirements for K9s
- Require annual reporting and accountability requirements for military working dogs and a prohibition on abandonment of military working dogs outside of the U.S.
- Require comprehensive Inspectors General oversight of U.S. aid to Ukraine, including end-user monitoring
- Require a plan to direct military construction funding to the Baltic states and Eastern Europe from Germany
- Increase funding for Space Force's rapid and responsive launch program
- Require a federal government strategy for research and development efforts on blockchain, or distributed ledger technologies
- Fully fund the Armed Overwatch program for the U.S. Special Forces
- Require the Defense Department to provide Congress with a plan to improve defense cooperation with Caribbean nations to combat Chinese influence in the country
- Restrict the sale of certain Chinese products in U.S. military base exchanges or commissaries
- Mandate a review of all members of the Armed Forces identified in criminal investigations from the Guard Recruiting Assistance Program and giving them an opportunity to appeal their designation

- Authorize the Defense Department to acquire flexible workspace services, to include spaced configured for classified information use, to attract and retain top technology personnel
- Repeal the Post-Widow's Tax, allowing veterans that withdrew from the Survivor Benefit Program due to the Dependency and Indemnity Compensation offset, to re-enroll and catch-up on missed payments
- Allocate additional funding for procurement of Florida-made Sonobuoys for the U.S. Navy
- Prohibit Joint Use Authorization for civil aviation at the Homestead Air Reserve Base

Voted in favor of the *Fiscal Year 2024 National Defense Authorization Act* (NDAA). This year's defense bill included many of my provisions and policy goals to:

- Expand qualifications for Junior Reserve Officers' Training Corps (JROTC) administrators and instructors
- Increase number of service academy nominations made by Members of Congress from 10 to 15
- Expand the Department of Defense's Troops-to-Teachers program to include JROTC instructors and administrators and reauthorize the program for another two years
- Increase minimum standards on the Army Combat Fitness Test for certain service members serving in combat arms occupational specialties
- Prohibit use of Federal funds to promote or teach critical race theory at Service Academies, in military training, or professional military education
- Require assessment of the capacity of the Department of Defense to routinely train, test, evaluate, and qualify theater-level operations in support of the Pacific Deterrence Initiative
- Require a biannual briefing on submarine readiness
- Prohibit Department of Defense contracts with any company that has business with the Putin regime or any natural gas, oil, and coal company operating in Russia (KREMLIN Act)
- Require report relating to allied and partnered support to Ukraine, including military contributions made by allied and partner countries
- Prohibit the establishment or maintenance of a unit of JROTC at an educational institution owned, operated, or controlled by the Chinese Communist Party
- Authorize certain remarried surviving military spouses to use commissary stores and Morale, Welfare, and Recreation retail facilities
- Secured funding for Sonobuoys, Armed Overwatch, Tactically Response Space, Airborne Augmented Reality for Pilot Training, Army Space Systems Integration, and Special Operations Non-Traditional ISR

Introduced the bicameral [*Preserving the Gulf Test Range to Ensure Military Readiness Act*](#) to prevent energy exploration and development that would jeopardize the Eastern Gulf Test Range.

Introduced the [*Abbey Gate Gold Star Families Dignified Transport Act*](#) to reduce the financial burden on families who have tragically lost a loved one in the service of our country and to

ensure the Pentagon covers the costs to transport a service members remains to a second location, so long as the second location is a National cemetery.

Introduced the [*Captain James C. Edge Gold Star Spouse Equity Act*](#) to allow surviving spouses of service members who died while on active duty to continue to receive their survivor benefits, regardless of marital status.

Introduced the [*Stop Funding JROTC at CCP-Owned School Act*](#) to prohibit the Department of Defense from establishing or maintaining a Junior Reserve Officers' Training Corps (JROTC) program at any private school owned by a subsidiary of the Chinese Communist Party. This bill was enacted into law by the FY24 NDAA.

Introduced the [*Sanctions Lists Harmonization Act*](#) to require coordination between the federal agencies managing prohibited party sanctions lists whenever a new entity is added.

Introduced the [*Further Strengthening America's Supply Chain and National Security Act*](#) to combat America's dependence on China for pharmaceuticals and to address associated supply chain risks that lead to shortages of critical drugs.

Introduced the [*WARRIOR Act*](#) to provide much-needed reforms to prevent the Biden Administration from further politicizing the Department of Defense and improve military readiness. The FY24 NDAA enacted 7 provisions from this bill into law.

Introduced the [*United States-Israel PTSD Collaborative Research Act*](#) to leverage research by the American and Israeli universities and nonprofits to treat post-traumatic stress disorder (PTSD).

Cosponsored the [*Strengthening Tools to Counter the Use of Human Shields Act*](#) to enhance sanctions enforcement and implementation against terrorist organizations that use innocent civilians as human shields - a scheme Hamas terrorists are employing following their horrendous attack on Israel on October 7th, 2023.

Cosponsored the [*United States-Israel Future of Warfare Act of 2023*](#) to require the Department of Defense to establish the United States-Israel Future of Warfare Research and Development Fund to conduct collaborative defense projects between the United States and Israel in areas of emerging technologies (e.g., artificial intelligence).

Cosponsored the [*Healthcare Equality and Rights for Our Heroes Act*](#) to grant service members who are victims of medical malpractice in a DoD medical treatment facility the right and opportunity to take their claim to District Court.

Cosponsored the [*Health Care Fairness for Military Families Act of 2023*](#) to extend health care coverage to TRICARE (Active Duty and Retired) beneficiaries who have adult children younger than 26 years old, lowering costs and ensuring access for hundreds of thousands of military families across the country.

Cosponsored the [*Respect for Grieving Military Families Act*](#) to prevent immediate recoupment and overdraft fees and would give family members the opportunity to repay any overpayment of benefits over a 12-month period. It would also allow the Secretary of Defense to forgive the repayment.

Cosponsored the [*Pay Our Troops Act*](#) to ensure our military will continue to be paid in the event of a Government shutdown.

Cosponsored the [*Department of Defense Student Financial Literacy Act*](#) to include financial literacy education as a graduation requirement in high schools operated by the Department of Defense Education Activity.

Cosponsored the [*Combating Racist Training in the Military Act of 2023*](#) to prohibit the Armed Forces and academic institutions of the Department of Defense from promoting Critical Race Theory.

Cosponsored the [*Religious Insignia on Dog Tags Act*](#) which would allow companies with a trademark license for military emblems to produce dog tags with religious insignia.

Cosponsored the [*Make American Flags in America Act of 2023*](#) which requires the federal government to only buy flags completely produced and manufactured in the United States.

Cosponsored the [*Protecting Military Installations from Foreign Espionage Act*](#) which would stop U.S. adversaries from acquiring land near military bases, and military areas, and putting our military operations and national security at risk.

Cosponsored the [*FORCE Act*](#) to prohibit removing Cuba from the list of state sponsors of terrorism until the President makes the determination that a transition government in Cuba is in power.

Cosponsored the [*Maintaining North Korea's seizure of the vessel USS Pueblo and its detention of the crew were in violation of international law and seeking the return of the USS Pueblo to the United States*](#) resolution.

Cosponsored the [*PRIMED Act*](#) to make certain actions taken by the Department of Defense to secure critical materials for energy infrastructure (e.g., minerals) eligible for an expedited

environmental review by including those projects within the scope of covered projects under the Fixing America's Surface Transportation (FAST) Act.

Cosponsored the [*Fighter Force Preservation and Recapitalization Act of 2023*](#) to prevent the closure of Air National Guard (ANG) fighter squadrons at a time when pilot and maintenance manning are at critically low levels.

Cosponsored the [*COVID-19 Origin Act of 2023*](#) to require the Office of the Director of National Intelligence (ODNI) to declassify all information relating to potential links between the Wuhan Institute of Virology and the origin of COVID-19

Cosponsored the [*Air America Act of 2023*](#) to award payments to employees of Air America who provided support to the United States from 1950 to 1976.

Led [letter](#) to Secretary of the Army Christine Wormuth calling on her to release the Army's recruiting survey dataset to better inform Congress's efforts to address the historic military recruiting crisis.

Led [letter](#) to Secretary of the Army Christine Wormuth to question where the solar panels installed at Army facilities are made and raise concern for our military's reliance on China for critical minerals and elements needed to implement the ambitious 2022 Army Climate Strategy.

Cosponsored the [*Paws Off Act of 2023*](#) to forbid the sale of food that contains xylitol unless the food's label contains a warning about the toxic effects of xylitol for dogs if ingested.

Cosponsored [*Violet's Law*](#) to require federal research facilities to facilitate the adoption or non laboratory placement of dogs, cats, nonhuman primates, guinea pigs, hamsters, and rabbits with animal rescue organizations, animal sanctuaries, animal shelters, or individuals.

AGRICULTURE

Our farmers and growers play an integral role in Florida's economy. This year, I focused on protecting Florida's agricultural industries and those who help put food on our tables.

Introduced the [*Sturgeon Conservation and Sustainability Act*](#) to allow American farmers to continue their sturgeon operations while also ensuring the longevity of the species across the globe.

Cosponsored the [*Block Grant Assistance Act of 2023*](#) to authorize block grants to states and territories to assist agricultural producers with losses due to droughts, wildfires, hurricanes, floods, derechos, excessive heat, tornadoes, winter storms, freeze, smoke exposure, and excessive moisture occurring in calendar year 2022.

Cosponsored the [*Land Grant Research Prioritization Act of 2023*](#) to amend the Food, Agriculture, Conservation, and Trade Act of 1990 to include additional priorities such as research and extension initiatives.

Cosponsored the [*Protecting America's Agricultural Land from Foreign Harm Act of 2023*](#) to prohibit the purchase or lease of agricultural land in the United States by persons associated with certain foreign governments.

Cosponsored the [*Defending Domestic Orange Juice Production Act of 2023*](#) to direct the U.S. Food and Drug Administration (FDA) to lower the required level of sugar/solids content (Brix standard) in not-from-concentrate pasteurized orange juice from 10.5 percent weight of orange juice soluble solids to 10 percent.

Cosponsored the [*PROTECT Florida Act*](#) to provide for a moratorium on oil and gas leasing and exploration on the outer Continental Shelf off the coast of Florida until 2032.
